



This is to certify that Miss Dympia Mullen (now Mrs. O'Halloran) rendered very valuable assistance to the Monaghan Brigade from 1917 to 1921. She nursed our wounded notably Capt. Owen Keenan R.I.P., and M. Kelly R.I.P. She was entrusted with the transfer of arms and ammunition from Dublin to our Brigade H.Q.'s, and she was recognised as our most reliable dispatch carrier.

Her father, Peter Mullen Co.Co., was one of the first public men in Co. Monaghan to openly declare himself for the Sinn Fein movement and her sister Miss Alice Mullan was County President of Cumann na mBan 1917-'21. He Uncle Very Rev. Fr. Quigley, P.P., Newbliss was one of the best supporters of the Cause in our Brigade area, and another uncle, James Quigley B.E., then County Surveyor of Meath took a prominent part in Easter Week - leading the Volunteers from his area to Dublin.

Miss Dympia Mullan herself has a first class National record, and deserves well of the Government of the day.

Sir, I understand that Mrs. O'Halleran has applied for a I beg to offer verification of her Claim to Service. Pensien. I have knewn her all her life particularly throughout the 1918 - 1921. Her Services as a trained nurse were always at the dispesal of the Volunteers during that period and were availed of on several occasions. Once a wounded Volunteer was nursed by her night and day, in her own house, where he actually died. I also know that she had other patients in the town (Menaghan) at the same time which she attended as well. In the winter of 1920 - 1921 when Volunteer Mick Kelly was shot through the chest in a 'B' Special Ambush she was quickly en the job, although he died the same night. Apart from Nursing, Mrs. O'Halloran also helped in the transmission of despatches - although her house was raided several times by Military and Black & Tans. On one occasion she went to Dublin by rail and helped to bring down a supply of Ammunition from Dublin which was urgently required. Normally the connection to Monaghan is through Clones but on this occasion the train had to go on to Portadown where a delay of Two Hours (waiting for a connection) considerably increased the risk, but the material was safely delivered. It is very difficult at this stage to recall the events of that period accurately. Dates I cannot give with any degree of exactness but I know that Mrs. O'Halleran was a very enthusiastic worker and I have the utmost confidence in the justness of her Claim which I wholeheartedly recommend. During the Period referred to I was successively Adjutant and Captain of Monaghan Company, 2nd. Battalion. RECEIVED 15 JUL 1937 Mr Twomen Joseph Brannigan commandant.

This applicant was trained as a Nurse in St. Vincent's Hospital, Dublin, and on the completion of her training in February, 1920, she returned to Monaghan and joined the Cumann na mBan under her sister whom was Capt. of the Coy. She nursed Vol. Keenan in her own house for two weeks before he died. She also nursed Vol. Mick Kellay for one day in his own house and assisted at an operation carried out following which he died. She had two further cases of nursing for a few days each. With her sister she carried a bag of ammunition from Dublin to Monaghan on one occasion. She received and forwarded despatches about a dozen times. She joined the Army Nursing Service in October 1922 and remained in it for six years.

STATEMENT MADE BEFORE ADVISORY COMMITTEE Mrs. DYMPNA O'HAIMORAN (Née Mullan) on 16/7/37 Have you any refs.?

A. I have. I was told there were two sent in yesterday, one from John O'Duffy and from Comdt. Branagan. I see you were trained as a General Nurse in Vincents'? Q. Yes. And your training fins shed in Feb. 1920? That is right. You were three or four years training?
Three; I got off with three. T got the full Cert. of course for that. A. You finished your training in Feb. 1920? Yes, I went back down home then to Monaghan town. A. Did you join up with Cumann na mBan straightaway then? I did. I could not give you the exact date. My sister was the Capt. and I joined in, but I never went to very many of the drills because I was the nurse. My sister was to be heard on Wednesday. She was the presentation Organiser and Capt. Nursed wounded Vols. in my own house and other houses? Yes, Ned Keenan (Owen). This little fellow was shot when they were out raiding for arms. They were searching for him everywhere. They did not know where to hide him, so he was brought into our house in Monaghan. I think he lived for about a fortnight. Did you nurse him for the fortnight? Q. Yes, of course I did, for night and day. I was the nurse. Dr McCarvill used to come int now and again. Did your sister help in the nursing?
She was not nursing, but she was in and out. Of course there was a business place not underneath, and she used to run the business. There was another fellow, Mick Kelly,

— I think he was later on. He was shot by Specials.
He died in his own house then. He was shot early in the morning. I was brought box to him, and Surgeon Meade was brought to him and he went to operate on him and he died on the table on us that right the table on us that night. You assisted at the operation? Yes, I had everything ready for the surgeon. Q. Where was this operation? At his own house in Lock(?) St., Monaghan. Who came down for the operation? A. Surgeon Meade. Any other cases of nursing people?
There were two others knocked out on the same raid as Q. Keenan. One was a finger and the other a big toe.
Dr. McCarvill amputated both the finger and toe; but it was only for a couple of days.

- Q. Where were they?
 A. In Dr. Halpin's (McCarvill's) house, just on the outskirts of the town.
 - Was that your principal job in Cumann na mBan? It was the nursing side, except the time they sent us

 more to Dublin for ammunition. They ran very short of
 ammunition and they did not know who would get it down
 and so my sister had to go and myself, brought it down
 from Dublin. It was delivered to us to the hotel and we carted it down.
 - Have you any idea of the time of the year that was? I have not the remotest. I think I might have been a year back in Monaghan at the time. I know we had to go A. around to around by Portadown, a most dangerous place, because we could not go by train. And we could not give the bag to the porter and it was breaking our arms.

 That must have been the time. I may have got them
- mixed up.
- Have you told us of all the cases of nursing you had? I think so.

- Yes, myself and my sister used often cycle out here to different places. Sometimes she would go and sometimes A. she would ask me to go. I often took a dozen. I EXEN often went with her too. Sometimes she would go. They would often come by post in the morning. Sometimes they would be addressed to me.
- Were you doing any ordinary nursing in Monaghan at this time?
- No, I was not. I kept myself free in case the boys would want us. A.
- Were you doing any private nursing at all?
- A.
- You were not on the run?
- A. No.
- Was that the only occasion on which you had to carry Q.
- That was the only time we were asked to carry them. A.
- Is there anything else you can think of in the Black and Tan time?
- Except a few times we used to be xraided and things like that during the night and during the day.
- Joined the Army Nursing Service October 1922? Q.
- A. In Marlboro' Hall.
- Q. Did you stay long in the Army Nursing Service?
- I was in it six years. I was in it from when I joined A. in 1928.

Mrs. Dympna O'Halloran(née Mullen) was to my knowledge a member of the Cumann na mban during the Black and Tan war.

She was then a trained nurse and it was mostly in this capacity that I knew the services she rendered. At home in her native Monaghan she was always available and gave her services with the greatest readiness regardless of personal inconveniences or risk. Wounded volunteers were treated in her house and one of them died there after she and her aunt had given weeks of day and night attention, themselves providing the nursing requisites and maintenance for the man. She assisted me in emergency operations on several members of the volunteers, at times travelling distances unobtusively to avoid detection. I cannot speak too highly of the services given by herself and her family during the period stated.

APPENDIX.

FIRST SCHEDULE.

RULES FOR DETERMINING NOTIONAL GRADES OF RANK IN THE FORCES HELD BY PERSONS SERVING IN THE FORCES.

1.—(1) Any person who at any date was either Chief of Staff, Deputy Chief of Staff, Adjutant General, a Divisional Officer Commanding, or Quartermaster General shall be deemed to have held at that date Rank A.

(2) Any person who at any date was either—

- (a) a General Headquarters Officer acting as Director of any one of the following services, namely Organisation, Intelligence, Engineering and Munitions, or
- (b) a Brigade Officer Commanding whose brigade was at that date not less than one thousand in strength,

shall be deemed to have held at that date Rank B.

- (3) Any person who at any date was either—
 - (a) a Brigade Officer Commanding whose brigade at that date was less than one thousand in strength, or
 - (b) a Divisional Vice Officer Commanding, or
 - (c) a Divisional Adjutant, or
 - (d) a Divisional Quartermaster, or
 - (e) a Battalion Commandant whose battalion was at that date not less than three hundred in strength, or
 - (f) a Brigade Vice Officer Commanding whose brigade was at that date not less than one thousand in strength, or
 - (g) a Brigade Adjutant whose brigade was at that date not less than one thousand in strength, or
 - (h) a Brigade Quartermaster whose brigade was at that date not less than one thousand in strength, or
 - (i) a Column Commander whose column was at that date not less than thirty in strength, or
 - (j) a General Headquarters Officer who at that date was acting as Director of Medical Services, or
 - (k) a General Headquarters Officer who at that date was acting as Director of any Service, other than that of Medical Services, or one of the Services mentioned in sub-paragraph (a) of the immediately preceding paragraph,

shall be deemed to have held at that date Rank C.

- (4) A person who at any date—
 - (a) was a Battalion Commandant whose battalion at that date was less than three hundred in strength, or
 - (b) was a Company Captain whose company at that date was not less than sixty in strength, or
 - (c) was, at that date, a Captain on the General Headquarters Staff or on a Divisional Staff, or
 - (d) was, in the case of a company which at that date was not less than one hundred and twenty in strength, where the company had at that date one Lieutenant only, such Lieutenant or, where the company had at that date two Lieutenants only, one or other of such Lieutenants, or, where the company had at that date three or more Lieutenants, one or other of the two Lieutenants who were at that date respectively second and third in command, or
 - (e) was, in the case of a company which at that date was less than one hundred and twenty in strength but not less than one hundred in strength, where such company had at that date one Lieutenant only, such Lieutenant or where such company had at that date two or more Lieutenants, the Lieutenant who was at that date second in command, or
 - (f) was a Brigade Officer, other than a Brigade Officer who is deemed by virtue of paragraph (2) or (3) of this Rule to have held at that date either Rank B or Rank C, or
 - (g) was a Battalion Vice Officer Commanding whose battalion at that date was not less than one hundred in strength, or
 - (h) was a Battalion Adjutant whose battalion was at that date not less than one hundred in strength, or
 - (i) was a Battalion Quartermaster whose battalion was at that date not less than one hundred in strength, or

- (j) was a General Headquarters Officer other than a General Headquarters Officer who was at that date acting as a Director of any Service, or
- (k) was a Divisional Officer other than a Divisional Officer Commanding, a Divisional Vice Officer Commanding, a Divisional Adjutant or a Divisional Quartermaster, or
- (l) was a Column Commander whose column at that date was less than thirty in strength, or
- (m) was a Medical Officer other than a General Headquarters Officer who at that date was acting as Director of Medical Services,

shall be deemed to have held at that date Rank D.

- (5) Any person who complies with the following conditions, namely:
 - (a) was at any date an officer, and
 - (b) is not deemed by virtue of any of the preceding paragraphs of this Rule to have held at that date any grade of rank,

shall be deemed for the purposes of this Act to have held at that date Rank E.

- (6) Any person who at any date held the rank of non-commissioned officer or private shall be deemed to have held at that date Rank E.
- (7) None of the foregoing provisions of this Rule shall apply to any person who at any date was a member of Fianna Eireann or of Cumann na mBan and was not at any date a member of Oglaigh na hEireann (Irish Republican Army) or of the Irish Volunteers, and in lieu thereof the following provisions shall have effect in relation to any such person, that is to say:—
 - (a) any person who at any date:—
 - (i) was a member of the headquarters staff or executive of Fianna Eireann or Cumann na mBan, or
 - (ii) was an officer of Fianna Eireann or Cumann na mBan commanding one hundred members or more of either of those bodies, or
 - (iii) was an officer of Fianna Eireann or Cumann na mBan senior to an officer of either of those bodies commanding one hundred members or more of either of those bodies,

shall be deemed to have held at that date Rank D, and

- (b) any person who at any date was a member of Fianna Eireann or Cumann na mBan and who is not deemed by virtue of the foregoing sub-paragraph (a) of this paragraph to have held Rank D, shall be deemed to have held at that date Rank E.
- 2. Where an officer whose grade of rank at any date is, under Rule I of this Schedule, to be determined both by his actual rank in the Forces and the strength of the unit to which he belonged at that date, and such officer is, at that date, absent from duty by reason of imprisonment on account of his activities as a member of the Forces, the following provisions shall, for the purposes of the said Rule I, have effect in relation to such officer, that is to say:—
 - (a) such officer shall be deemed to have held at that date the actual rank in the Forces which he held at the date of his arrest, and
 - (b) such unit shall be deemed to be at that date at the same strength as it was at the time of his arrest.
- 3. Where the case of any person does not fall within the provisions of Rule I of this Schedule, the Referee may determine the particular grade of rank which such person is to be deemed to have held on any date, and in so determining the Referee shall have regard to the following matters, that is to say:—
 - (a) the appointment held by such person,
 - (b) the services performed by such person,
 - (c) the principles of grading set forth in the said Rule I.
- 4. Where any person, whose case at a particular date falls within the provisions of Rule I of this Schedule, was, at that date, engaged in service of a special character, the Referee may, in making his report under this Act in relation to the grade of rank held by such person on such date, report that the grade of rank held by him on such date is a grade of rank higher than the grade which, but for this Rule, would be the grade of rank held by him on that date.

DEFINITION OF THE FIRST AND SECOND CRITICAL DATES.


1. In the case of a person who served in the Forces during the period commencing on the 1st day of July, 1922, and ending on the 30th day of September, 1923,

The expression "the first critical date" means the 11th day of July, 1921; and the expression "the second critical date" means:—

- (a) in the case of a person who served in the Forces on the 1st day of July, 1922, the 1st day of July, 1922 and
- (b) in the case of a person who did not serve in the Forces on the 1st day of July, 1922, but who served in the Forces at any time during the period commencing on the 2nd day of July, 1922, and ending on the 30th day of September, 1923, the date during that period on which such person first served in the Forces.
- 2. In the case of a person who did not serve in the Forces during the period commencing on the 1st day of July, 1922, and ending on the 30th day of September, 1923, but who has either:-
 - (a) served in the Forces at any time during the week commencing on the 23rd day of April, 1916,
 - (b) served in the Forces continuously during the period commencing on the 1st day of April, 1921, and ending on the 11th day of July, 1921,

the expression "the first critical date" shall be construed as meaning the date during the said week, or if he did not serve during the said week, during the said period, on which he first served in the Forces in such week or such period (as the case may be), and

the expression "the second critical date" shall be construed as meaning the earliest date in the period between the first critical date in respect of such person, and the 12th day of July, 1921, on which such person held his highest rank in such last-mentioned period in the Forces.
