Reference your A/3935 of the 19th Applicant's statements in respect of the deceased, Cornelius Murphy, are correct.

Deceased, at the time of his arrest was Captain /A" Company, 7th Battalion, 2nd Cork Brigade, and was attached to an A.S.U. Surprised by Crown Forces near Rathmore, while operating within A.S.U., he made a determined effort to outwit his captors but was unsuccessful. He was in possession of a revolver. He was conveyed to Cork, tried and sentenced to death, the execution taking place on 1st February 1921. The result of the trial was made known only after this date.

Applicant was partially dependent on deceased, who was captured in the course of his duty, and death was not due to any negligence or misconduct on his own part.

Applicant's claim is recommended for favourable consideration.
