With reference to your letter of the 15<sup>th</sup> instant, requesting an application form under the Military Service Pensions Acts, I am directed by the Minister for Defence to inform you that the statutory time limit for the acceptance of completed forms of application from persons who had not previously made application under those Acts expired on the 18th March, 1955. ✓

The Minister has no discretionary power under existing legislation to accept an application after the expiration of the statutory time limit. In the circumstances, it is regretted that no action can now be taken in the matter and no useful purpose would be served by issuing an application form to you at this stage. *A further communication will be addressed to you regarding your application for a Pension (1917-1921) Medal.*

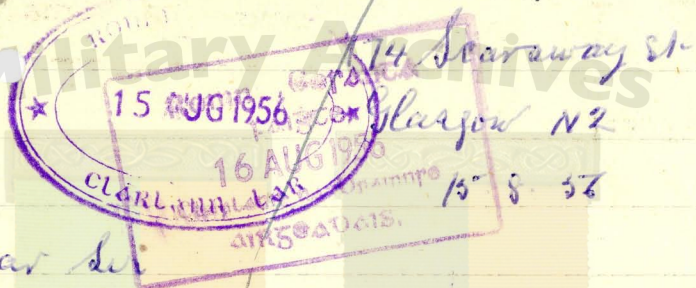
