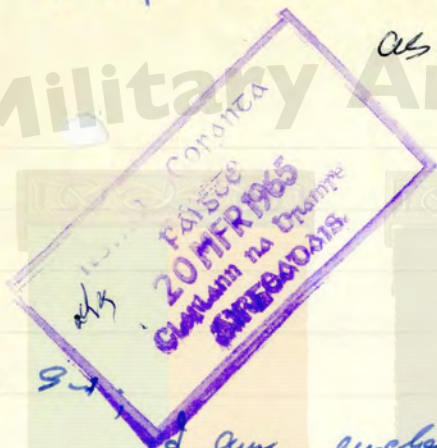

I am to add that pensions such as this are personal to the holder and cease at death and there are no provisions in the Military Service Pensions Act to enable such a pension or any part thereof to be paid to the next-of-kin of a deceased person.
