Deceased, Sergeant Patrick McCabe of Bawn Cortubber aforesaid was a full brother of the Applicant. He was a Free State soldier and held the rank of ~~EXPXKIN~~ Sergeant. He was stationed in Carrickmacross Co. Monaghan. On the morning of 5th September 1922 the Barrack was attacked by Irregulars (it is supposed) & Sergt McCabe was shot dead.
