I am to point out that, for the purposes herein, a person shall be deemed to have been engaged in Military Service when, but only when, he was on duty as a member of the organisation referred to, or was under arrest as a result of his activities as such member, or being such member was evading capture or pursuit by the armed forces of the British Government or of the Government of Saorstát Eireann or of the Provisional Government or of the Government of Northern Ireland, or being such member was detained in a prison or ship, or an internment camp by or by order of any of the said Governments.
